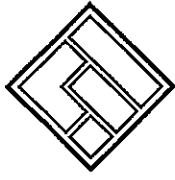

DIRECTORS' REPORT

Your directors present their report on the company and its controlled entities for the half year ended 31 December 2009. Provet Holdings Limited is a company limited by shares that is incorporated and domiciled in Australia.

Directors have been in office since the start of the financial year to the date of this report unless otherwise stated.

Review and Results of Operations

In October 2009, the company completed a successful non renounceable right issues of 1 new share for every 3 existing shares which raised \$12.4m and was underwritten by LCW Private Equity. Following the rights issue, further shares were issued in the form of placements totaling \$2.8m in November 2009. A share split of 4 new shares for every 1 existing share was then completed in December 2009, following shareholder approval at an Extraordinary General Meeting.

The financial results for the half year ending 31 December 2009 are very pleasing and support the focus that management have on completing the final bedding down of acquisitions that have occurred over the last few years and on improving profitability.

While sales for the group have increased marginally over the same period last year by \$3.2m or 2.3%, our Australian distribution operations have noted a satisfying sales increase over the prior year of 5% given the economy is still emerging from the effects of a difficult financial market and lower consumer confidence. The benefits of a diversified geographical sales market for the Provet group have been particularly evident given the profitability of our operations in New Zealand have come under pressure with the less than favourable economic and agricultural environment that currently exists, with particular impact on the dairy sector.

The total net profit before tax (NPBT) result for the group was \$4,728,336 (2008: \$2,826,651) which is up on last years reported profitability by \$1.9m or 67%. After adjusting the prior years result for the write off of \$282,000 (net of tax) in capitalised IPO costs, the result is a 52% increase in NPBT. This is a significant result for the Provet Group and follows on from a market profit guidance statement released in January 2010 indicating an increase in excess of 30% over last years NPBT result is anticipated for the full year June 2010. The improved result is due to a number of factors:

- Solid organic growth year to date for our Australian wholesale distribution operations;
- Increased efficiencies and cost savings for the wholesale distribution operations;
- Improved profitability of our value add business units incorporating the Practice Management Software and the Training and Consulting businesses; and
- Reduced interest expense on debt funding.

Subsequent Events

Provet now has a truly national footprint with the commencement of operations out of a purpose built warehouse in Cambridge in Tasmania on 11 January 2010. Provet is the only veterinary wholesaler to commit to a physical presence in Tasmania.


DIRECTORS' REPORT Continued


Auditor Independence and Non-Audit Services

Note 1 – Corporate information

The financial report of Provet Holdings Limited (the Company) for the half year ended 31 December 2009 was authorised for issue in accordance with a resolution of the directors on 25 February 2010.

The financial report covers the economic entity of Provet Holdings Limited and its controlled entities. Provet Holdings Limited is a non-listed public company, incorporated and domiciled in Australia.

Note 2 – Summary of Significant Accounting Policies

Basis of preparation

This general purpose condensed financial report for the half-year ended 31 December 2009 has been prepared in accordance with AASB 134 *Interim Financial Reporting* and the *Corporations Act 2001*.

The half-year financial report does not include all notes of the type normally included within the annual financial report and therefore cannot be expected to provide as full an understanding of the financial performance, financial position and financing and investing activities of the consolidated entity as the full financial report.

It is recommended that the half-year financial report be read in conjunction with the annual report for the year ended 30 June 2009 and considered together with any public announcements made by Provet Holdings Limited and its controlled entities during the half-year ended 31 December 2009 in accordance with the continuous disclosure obligations arising under the *Corporations Act 2001*.

Apart from the changes in accounting policy noted below, the accounting policies and methods of computation are the same as those adopted in the most recent annual financial report.

Basis of consolidation

The half-year consolidated financial statements comprise the financial statements of Provet Holdings Limited and its controlled entities as at 31 December 2009.

New Accounting Standards and Interpretations

AASB 101 Presentation of Financial Statements

The revised Standard separates owner and non-owner changes in equity. The statement of changes in equity includes only details of transactions with owners, with non-owner changes in equity presented in a reconciliation of each component of equity and included in the new statement of comprehensive income. The statement of comprehensive income presents all items of recognised income and expense, either in one single statement, or in two linked statements. The Group has elected to present two statements.

AASB 8 Operating Segments

AASB 8 replaced AASB 114 *Segment Reporting* upon its effective date. As the Group is in the process of listing its shares on the ASX it is required to comply with the disclosures outlined in the newly issued standard. AASB 8 disclosures are shown in note 12, including the related revised comparative information.

Acquisitions and disposals

During the half-year ended 31 December 2009, the Group acquired assets with a cost of \$1,550,453 (2008: \$767,441).

Assets with a net book value of \$112,931 were disposed of by the Group during the half-year ended 31 December 2009 (2008: \$63,610), resulting in a loss on disposal of \$7,658 (2008: \$17,703).

Note 6 – Interest Bearing Loans and Borrowings

During the half year the Group recorded:

- net repayment of both short and long term bank debt of \$8,858,592 (2008: borrowings of \$2,863,609)
- foreign exchange gain on \$NZD short and long term debt of \$2,713 (2008: loss of \$30,121)
- net decrease in lease, hire purchase and chattel mortgage financing of \$5,215 (2008: decrease of \$108,606)

Note 12 – Operating Segments

Identification of reportable segments

The Group has identified its operating segments based on the internal reports that are reviewed and used by the executive management team (the chief operating decision makers) in assessing performance and in determining the allocation of resources.

The operating segments are identified by management based on the nature of the product or service being provided by the operating business units. Discrete financial information about each of these operating businesses is reported to the executive management team on at least a monthly basis.

The reportable segments are based on aggregated operating segments determined by the similarity of the products produced and sold and/or the services provided, as these are the sources of the Group's major risks and have the most effect on the rates of return.

Reportable Segments

Wholesale Operations

The wholesaling operations offer a full range of veterinary products to customers within the veterinary industry across Australia and New Zealand.

Information Technology

The information technology business unit develops, sells and supports Veterinary practice management software, internet business portals and other technological based services to the veterinary industry across Australia and New Zealand. The business unit also support the Groups internal information technology needs.

Training and Consulting

The Groups training and consulting operations provide value add services to the wider Veterinary profession.

Accounting policies and inter-segment transactions

The accounting policies used by the Group in reporting segments internally are the same as those contained in note 1 to the accounts and in the prior period except as detailed below:

Inter-entity sales

Inter-entity sales are recognised based on an internally set transfer price. The price is set annually to reflect what the business operation could achieve if they sold their output and services to external parties at arm's length.

Corporate charges

Corporate charges comprise non-segmental expenses such as head office expenses and interest. Corporate charges are allocated to each business segment on a proportionate basis linked to segment revenue so as to determine a segmental result.

The following items and associated assets and liabilities are not allocated to operating segments as they are not considered part of the core operations of any segment:

Inter-company Dividend revenue.

Appreciation/diminution of investments held for sale

Fair value gains/loss on cash flow hedges

Movements in Foreign Currency Translation reserves

Revaluation of land and buildings

Impairment of assets - impairment of assets are not included in the measurement of segment profit




